PRESS NOTE

It is to intimate to all concerned that the Andaman and Nicobar Administration has enhanced the hiring charges for the Dry-docks (both Old and New) and Slipways functioning under the Directorate of Shipping Services, Andaman and Nicobar Administration, Port Blair with immediate effect. The revised tariff charges are as follows:

Day of Un-docking/Un-slipping)	Rs. 59,850/-	Rs. 49,950/-	Rs. 19,900/-

(Service Tax shall be levied extra)

Terms and Conditions:

- 1. The tariff charges for the period of indented/allotted Dry-dock or Slipway will be required to be paid in advance by the Owner of the vessel.
- 2. In case of any delay in Un-docking/Un-slipping, the per day charges of docking/slipping will be doubled from the scheduled date of Un-docking/Un-slipping.
- 3. An amount of Rs. 50,000/- (Rupees fifty thousand only) shall be deposited by the user Agency in advance, as a Security Deposit, to ensure that the Dry-dock/Slipway is cleaned by the agency after its usage. The Security Deposit shall be returned after satisfactory cleaning of dust/garbage generated during repair of the vessel.
- 4. The Department shall charge Rs. 3,300/- per hour plus Service Tax for providing the services of the Mobile Crane and @ 965/- per ton plus Service Tax for providing Electric connection for renewal of steel plates.
- 5. In case the booking of Dry-dock/Slipway is cancelled without giving 48 hours notice in advance, the 25% of the Dry -dock/Slipway charges will be recovered from the Owner of the vessel.
- 6. (a) If a vessel heels over to one side or the other at the time of Docking/Un-docking, contrary to the declaration made in the Tank declaration by the Master of the vessel, an additional charges of Rs. 9,000/- (Rupees nine thousand only) will be levied for correcting the same. If however, it is considered necessary to dewater the dry-dock for re-setting blocks, extra Docking charges will be levied which means the vessel will be required to pay the additional docking and un-docking charges for the same.

- (b) If a vessel heels over to one side or the other at the time of Slipping/Un-slipping contrary to the declaration made in the Tank Declaration by the vessel or Owner of the Boat, an additional charges of Rs. 6.000/- (Rupees six thousand only) will be levied for correcting the same. If however, it is considered necessary to take it on the Slipway again the setting of the Block, the Slipway charges will be levied which means the vessel will be required to pay the additional Slipping and Un-slipping charges for the same.
- 7. If a vessel discharges oil or other debris in the Dry-dock/Slipway, she will be levied cleaning charges of Rs. 1,500/- (Rupees one thousand and five hundred only) and additionally a fine Rs. 1,000/- (Rupees one thousand only) will be charged.
- 8. The charges for services of 10 ton Wharf Crane and 55 ton Mobile Crane on the day of Dry-docking /Un-docking & shore supply electrical connections are included in the Docking/ Un-docking tariff.
- 9. All tariff fares/charges will be revised upwards by 10% every year unless otherwise promulgated.
