**Schedule of Spot Round registration and choice filling for CSAB-NEUT counselling**

In continuation to the Administration's press release published in The Daily Telegram on 003.08.2017, it is brought to the notice of all concerned candidates of A&N Islands that the CSAB NEUT-2017 has provided the following revised schedule to accommodate the new registrants for allotment of vacant seats of B.Tech and B. Architecture courses for Spot Round counselling:-

ii	<b>Spot Round counselling will be conducted in the Auditorium of JNRM, Port Blair</b>	<b>August 8, 2017 (10.00 AM onwards)</b>
iii.	Reporting at the admitting Institute	Aug 9-14, 2017

There will be no change for the Pharmacy Schedule already announced earlier.

The Spot Round allotment will be made to candidates who report as per merit and category-wise list of vacant seats provided by the CSAB NEUT-2017 at the time of counselling.

All interested candidates are requested to do the registration and choice filling process for vacant seats of B.Tech/B.Arch course as per the above schedule. The registered candidates are required to bring all educational qualification certificates/testimonials and other documents in support of their category in original alongwith one self attested copy as prescribed by the CSAB NEUT-2017 in their Information Brochure except Demand Draft for spot round counselling on the date time and venues as specified above. In addition, the candidates are also requested to bring two passport size photographs identical to the one pasted on the JEE (Main) 2017 application form and 2 permanency certificates for sureties.

Further, the aspiring students are advised to ensure that he/she fulfills the state eligibility criteria before choice filling. In case, if a candidate denied admission by the respective State/Institute, it will be solely responsible of the candidate, neither the A&N Administration nor the Govt. of India, MHRD or CSAB NEUT-2017 would be responsible.
