Governor, Andaman & Nicobar Islands hereby makes the following rules regulating the method of recruitment to the Group 'B' Gazetted post of Assistant Director (Tech.) in the Directorate of Industries, Andaman & Nicobar Administration, namely:-

**1. Short title and Commencement:-**

- (i) These Rules may be called as 'Andaman & Nicobar Administrator's Group 'B' Gazetted post of Assistant Director (Tech.), in Department of Industries, Recruitment Rule Amendment 2017".
- (ii) This rule shall come into force from the date of its publication in the Andaman & Nicobar Gazette.

**2. Number of posts, classification and scale of pay:-**

The number of post, classification and scale of pay attached thereto shall be as specified in Para 2 to 4 of the schedule annexed hereto.

**3. Method of recruitment, age limit and qualification:-**

The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in Para 5 to 14 of the said schedules.
