F.No.16-380/E/DA/2017 (PF) - In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Government of India, Ministry of Home Affairs, New Delhi Notification No.U-14039/2/83-ANL dated 21st February, 1985 and in supersession of Notification No. Lia 13015/1/77-SL&UT dated 02/09/1982, and in consultation with Union Public Service Commission vide Letter No..... dated....., the Lt. Governor (Administrator), Andaman & Nicobar Islands hereby makes the following rules regulating the method of recruitment to the Group 'A' Gazetted post of **Director of Agriculture** in the Department of Agriculture, Andaman & Nicobar Administration, namely:-

1. Short Title and Commencement:-

- i) These Rules may be called the Andaman and Nicobar Administration (Group 'A' Gazetted) post of **Director of Agriculture** in the Department of Agriculture, Recruitment Rules, 2018.
- ii) They shall come into force on the date of their publication in the Official Gazette.

2. Number of Posts, Classification and Scale of Pay:-

The number of said posts, its classification and Level in the Pay Matrix attached thereto shall be as specified in Column - 2 to 4 of the Schedule annexed thereto.

3. Method of recruitment, Age Limit & Other Qualifications:-

The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in Column - 5 to 13 of the Schedules annexed thereto.

4. Disqualification:-

No person -

- (a) Who has entered into or contracted a marriage with a person having a spouse living; OR
- (b) Who, having a spouse living, has entered into or contracted a marriage with any person(s) shall be eligible for appointment to the said post:

Provided that the Lieutenant Governor (Administrator), Andaman & Nicobar Islands may, if satisfied, that such marriage is permissible under personal law applicable to such persons and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rules.

5. Powers to Relax:-

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient to do so, he may by order for reasons to be recorded in writing, and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.

6. Savings:-

Nothing in these rules shall effect the reservation, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, Schedules Tribes and other categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
