MEMORANDUM

Sub: Offer of appointment to the post of Medical Officer in the A&N Health Department under A&N Administration - reg.

The Union Public Service Commission vide letter No. F.1/1(1)/2017-R.1 dated 17.07.2018, has recommended the following 14 candidates for recruitment against 42 (ST-01, SC-16, OBC-24 & UR-01 including 02-PH) for appointment to the Group 'A' Gazetted post of Medical Officer in A&N Health Department. Accordingly, she/he is hereby offer appointment to the post of Medical Officer on the following terms and conditions:-

1. On her/his appointment, she/he would take an oath of allegiance to the Constitution of India or make solemn affirmation to that effect in the prescribed form.
2. On appointment, she/he will be entitled to receive pay in the Pay Matrix Level-10 Rs.56100-177500/- (Revised) Rs.15600-39100 (PB-3) +GP of Rs. 5400/- + NPA (Pre-revised).
3. Private practice of any kind what so ever including laboratory and consultant practice is prohibited.
4. Non-practicing allowance is admissible according to orders/instructions of the Government, issued from time to time.
5. In addition to the Pay mentioned above, she/he will get Dearness Allowance, Special Compensatory Allowance, House Rent Allowance, Hard Area Allowance and Transport Allowance at the rates prescribed by the Central Govt. from time to time as admissible to the employees of similar categories of A&N Administration.
6. She/he will be required to submit a declaration in the prescribed form regarding her marital status and in the event she/he has more than one spouse living or being married to a person having more than one spouse living, the appointment will be subject to the being exempted from the enforcement of the requirement on this behalf.
7. She/he will be on probation for a period of two years from the date of appointment. The period of probation is liable to be extended at the discretion of the A&N Administration. Her/his services are liable to be terminated at any time during the period of probation after giving one month notice, if her/his work and conduct during the probation period are found to be unsatisfactory.
8. She/he will be liable to serve in any part of A&N Islands where Health Department unit/organization are located.
9. Her/his service shall be liable to terminate at any time on one month's notice without assigning any reason thereof.
10. She/he will be required to contribute for New Pension Schemes, which will have two Tiers; Tier-I contribution to Tier-I is mandatory for all government servants joining government service on or after 01.01.2004 whereas Tier-II will be optional and at the discretion of Government Servants and will also in accordance with the rules in force from time to time.
11. She/he will, if so required be liable to serve in defense service or post connected with Defense of India for a period not less than four years including the period spent on training if any, provided:-
 - a. The officer shall not be required to serve as aforesaid after the expiry of ten years from the date of appointment.
 - b. The officer shall not ordinarily be required to serve aforesaid after attaining the age of 45 years.
12. In respect of matters not specified above, her/his service shall be governed by the relevant rules, regulations and orders applicable to the officers/employees of similar status/ categories working under the A & N Administration.

13. The appointment is further subject to she/he being found medically fit for Govt. Service by the Competent Authority; and she/he being found suitable for Govt. service after verification of character and antecedents through concerned authority-District Magistrate/ Police.
14. If any declaration given or information furnished by her/him is proved to be false or if he/she found to have willfully suppressed any material information which would have rendered her unsuitable for Govt. employment, she/he will be liable to be removed from service, apart from any other action that may be taken against her/him under relevant rules/instruction.
15. The appointment is further subject to verification of her/his educational qualifications, age proof, category certificate and other testimonials by the department and if the verification reveals that the claim/certificates are false, her/his service will be terminated forthwith, without assigning any further reasons thereof.
16. She/he shall report for duty in the respective place of posting within a period of 30 days from the date of issue of the appointment order, failing which her/his appointment order shall stand cancelled.
17. She/he will be entitled to Leave Travel Concession as admissible under the Central Govt. Rules from time to time.
18. The Union Territory Government Employees Group Insurance Scheme, 1984, as modified from time to time, will be applicable to her/him.
19. No TA/DA will be admissible or allowed for joining the post on appointment.
20. The offer of appointment is provisionally pending verification of the veracity of her/his certificates.

Her/his acceptance of this offer of appointment or otherwise should be sent to the Principal Secretary (Health), A&N Administration, Secretariat, A&N Islands, Port Blair - 744101 by speed post within 30 days from the date of issue of the offer of appointment failing which the offer made to her/him will automatically be treated as cancelled without any further notice.
