### Terms and Conditions

1. Tenders will be received only in digitized form through e-procurement portal of the Andaman & Nicobar Islands Administration.
2. Tender documents would be received and opened through the e- procurement portal of the administration at the office of the ANIIMS,DHS Annexe Building, Port Blair-744104 as per the date and time specified in the tender documents.
3. EMD will also have to be submitted physically before the closing time at the office of the ANIIMS.
4. The lowest rate offered for items 1, 2 & 6 should be the L1 bidder, whereas for items 3,4 &5 , the L1 bidder will be decided on the basis of total amount of the rate quoted for items(3+4+5).
5. Performance guarantee @ 5% of supply order value in form of FDR /Bank Deposit drawn from any Nationalised Bank in an acceptance form in favour of "Director, ANIIMS, Port Blair", should be submitted within seven days from the date of acceptance of quotation.
6. EMD of the successful bidder will be returned on submission of performance guarantee. However, Performance Guarantee shall be released only after completion of guarantee period.
7. The items should be guaranteed for a period of one year or more from the date of supply. If any defect found during the guarantee period, the supplier should repair/replace the said item without extra cost, failing which Performance guarantee shall be forfeited.
8. The rate of 2 year AMC after guarantee period should also be quoted separately failing which quotation will be rejected.
9. The rate of the items should be exclusive of GST and the rate of GST should be quoted separately in the respective column.
10. The items should be delivered within 30 days from the date of supply order.
11. If the bidder fails to complete the supply in the stipulated time liquidated damages (LD) @ 0.5% of the contract value per week subject to a maximum of 05% shall be levied. On reaching the maximum LD supply order shall be liable to be cancelled and EMD/PG will be forfeited.
12. The firms should submit the GST registration number, failing which quotation will be summarily rejected.
13. The bidder should furnish attested copy of PAN Card.
14. The items should be delivered at DHS Annexe building office of ANIIMS, Port Blair.
