I am directed to say that the 07 (Seven) posts of Head Constables (Greaser) in the pay scale of Rs.5200-20200+GP Rs.2400/- are to be fill up on Re-employment amongst the eligible officers of Central/State Govt./UT Administration/ Autonomous Organization /Public Sector Undertaking.

Qualification/eligibility criteria required for the post of Greaser for Re-employment

“Serving Naval/Coast Guard Personnel/Ex-Naval/Coast Guard Personnel at least in the rank of Navik (ME)/Leading (ME) possessing minimum 15 years regular service of which at least 05 years experience as Greaser (Engine Side) of equivalent grade. Such official will be deputation term up to the date on which they are due for release from the Naval/Coast Guard and thereafter they may continue on re-employment. (Re-employment up to the age of superannuation with reference to civil post).

Terms & Conditions of Appointment on Re-employment.

- 1) In addition to pay, the selected person will be entitled to DA admissible to Government Servants at the Central Govt. rates.
- 2) Special Compensatory Allowance as admissible under rules.
- 3) Rent free unfurnished accommodation subject to general review or house rent allowance in lieu thereof.


- 4) Free Sea Passage once in a year for the Govt. Servant and their family members while proceeding/returning from leave in accordance with orders in force from time to time.
- 5) Leave travel concession as admissible under rules.
- 6) Deputation allowances as admission under rule.
- 7) The period of re-employment including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of Central Government shall ordinary not exceed 03 years. The maximum age limit for appointment on re-employment shall be, not exceeding 56 years, as on closing date of receipt of applications.
- 8) He shall be governed by relevant Rules and orders in force from time to time in respect of Government servants of their category serving under the Andaman & Nicobar Administration.

It is requested that the post may be circulated amongst the eligible officers working in the department under your control and the applications, alongwith the Curriculum vitae (CV) in the enclosed proforma of those officers who could be spared in the event of their selection, duly countersigned by the present employer, forwarded to the Director General of Police, A&N Islands, Port Blair- 744104 alongwith up to date ACRs, Vigilance Clearance and Integrity Certificate etc. by 25/8/2016..

Applications of those officers against whom disciplinary/vigilance cases are pending or contemplated need not to be forwarded. The applications received after the specified date and not accompanied by the above documents will not be entertained. Ex-service personnel are not required to submit ACR, but should provide supporting documents along with the Curriculum Vitae (CV).


