**Sub: - Filling up of 01 (one) post of "Research Officer" in Level-7 of the Pay Matrix (Rs. 44900-142400/-) through composite method (Deputation ISCT plus Promotion).**

It is proposed to fill up one post of "**Research Officer in the Directorate of Tribal Welfare, Secretariat Complex, A&N Islands, Port Blair**" (General Central Services Group 'B' Gazetted) in Level-7 of the Pay Matrix (Rs. 44900-142400/-) through composite method (Deputation ISCT plus Promotion)..

**1. Eligibility Conditions :-**

**Composite Method (Deputation (ISTC plus Promotion)**

1) Officers under the Central/State Govts./ Union Territories.

(A) (i) Holding analogous posts on regular basis in the parent cadre / department;

**OR**

(ii) With 5 (Five) years service in the grade rendered after appointment thereto on regular basis in **Level-6 (Rs 35400-112400) of the Pay Matrix** in the parent cadre/department;

**OR**

(iii) With 11 (Eleven) years service in the grade rendered after appointment thereto on regular basis in **Level-5 (Rs 29200-92300) of the Pay Matrix or equivalent** in the parent cadre/department;

**AND**

(B) Possessing Education qualification and experience prescribed for direct recruitment under Col. 7

**Essential:**

(i) Bachelor's degree from a recognized university or institute.


(ii) 5 years experience in the Administration of Tribal Welfare activities in a Govt. / Semi Govt. / Aided Organization / Recognized Institutions.

**Note 1:** Qualification(s) are relaxable at the discretion of the Union Public Service Commission for reasons to be recorded in writing in case of candidate otherwise well qualified.

**Note 2:** The qualification regarding experience is relaxable at the discretion of the Union Public Service Commission for reasons to be recorded in writing in the case of candidates belonging to scheduled castes / scheduled tribes, if at any stage of selection, the UPSC is of the opinion that sufficient numbers of candidates from these communities possessing the requisite experience are not likely to be available to fill up the post reserved from them.
