No...../F.No. 859/Sett/2021- The Lt.Governor, A&N Islands proposes to amend the Andaman & Nicobar Islands Land Revenue and Land Reforms Rules, 1968. The draft "Andaman & Nicobar Islands Land Revenue & Land Reforms (Amendment) Rules, 2021 is hereby published for the information of all concerned likely to be affected thereby.

Notice is hereby given that the said draft will be taken into consideration after 30 (Thirty) days from the date of publication. Any objections or suggestions which may be received from any person/authorities with respect thereto before the date specified above, will be considered by the Administrator/Hon'ble Lt. Governor. DRAFT AMENDMENT

1. Short Title and Commencement;

- (i) These Rules may be called the Andaman & Nicobar Islands Land Revenue and Land Reforms (Amendment) Rules, 2021.
- (ii) They shall come into force on the date of its publication in the official Gazette.

2. Rule 130 of the Andaman & Nicobar Islands Land Revenue and Land Reforms Rules, 1968 hereinafter called Principal Rules shall be substituted as under:-


"The village field map shall be prepared by the Settlement Officer during revenue survey operations using Chain/Electronic Total Station/Drone or such other devices as may be specified by Settlement Commissioner".

3. (i) Rule 132 of the Principal Rules shall be substituted as under-

"The Record of Rights shall be prepared in Form 'F' for each village both urban and Non-urban and shall be issued alongwith corresponding map, QR Code capturing village name, survey numbers, total area and name of the tenants."

- (ii) The Form 'F' prescribed under Rule 132 of the Principal Rules shall be substituted as appended herewith.
