This has the reference of this office letter no 7-1/ANCOL/Admission/2021-2022/513 dated 16/09/2021 and 7-1/ANCOL/Admission/2021-2022/515 dated 17/09/2021 and to place a Corrigendum as stated below:

The eligibility conditions for engaging Resources Person may be read as under.

**1. Eligibility For Humanities and Social Sciences**

- a) A Masters Degree with 55% marks (or and equivalent grade in a point – scale wherever the grading system is followed) in a concerned/relevant/allied subject from an indian university, or and equivalent degree from an accredited foreign university.
- b) Besides fulfilling the above qualification, the candidates must have cleared the national eligibility test (NET) conducted by the UGC or the CISR, or a similar test accredited by the UGC or who are or have been Awarded a Ph.D Degree in accordance with the university grants commission (minimum standards and procedure for Award of M.Phil/Ph.degree) regulations 2009 or 2016 and their amendments from time to time as the case may be exempted from NET.

**2. Eligibility for Performing Art (BPA-Hindustani Vocal and Instrumentations)**

- a) A Masters Degree with 55% marks (or and equivalent grade in a point - scale wherever the grading system is followed) in a concerned/relevant/allied subject from an indian university, or and equivalent degree from an accredited foreign university.
- b) Besides fulfilling the above qualification, the candidates must have cleared the national eligibility test (NET) conducted by the UGC or the CISR, or a similar test accredited by the UGC or who are or have been Awarded a Ph.D Degree in accordance with the university grants commission (minimum standards and procedure for Award of M.Phil/Ph.degree) regulations 2009 or 2016 and their amendments from time to time as the case may be exempted from NET.

**(Or)**

A traditional or a professional artist with highly commendable professional achievement in the subject concerned having a Bachelor's Degree, who has:

- 1) Studied under a noted/reputed traditional Master(s)/Artist(s).
- 2) Has been 'A' grade artist of AIR/Doordarshan
- 3) Has the ability to explain, with logically reasoning the subject concerned; and
- 4) Has adequate knowledge to teach theory with illustrations in the disciplin concerned.

The candidate those who are having above qualifications in concerned/relevant/allied subject can apply on or before 29/09/2021 in the prescribed proforma already published in the ANCOL website. The candidates already applied for Resources Persons with reference to previous notice no need to apply again, however if any changes or addition/ any document would like to attach they can submit during office hours on or before closing date.
