NOTIFICATION

No..... F. No. 859/Sett/2021, In exercise of the powers conferred by Sub-Section (1) of Section 210 of the Andaman & Nicobar Islands Land Revenue and Land Reforms Regulation 1966, the Lt. Governor (Administrator), Andaman & Nicobar Islands hereby makes the following Rules further to amend the Andaman & Nicobar Islands Land Revenue and Land Reforms Rules, 1968 namely:-

1. Short Title and Commencement;

- (i) These Rules may be called the Andaman & Nicobar Islands Land Revenue and Land Reforms (Amendment) Rules, 2021
- (ii) They shall come into force on the date of its publication in the Official Gazette.

2. Rule 130 of the Andaman & Nicobar Islands Land Revenue and Land Reforms Rules, 1968 (hereinafter called Principal Rules) shall be substituted as under-


“The village field map shall be prepared by the Settlement Officer during revenue survey operations using Chain/Electronic Total Station/Drone or such other devices as may be specified by Settlement Commissioner”.

3. (i) Rule 132 of the Principal Rules shall be substituted as under-

“The Record of Rights shall be prepared in Form F for each village both urban and non-urban and shall be issued alongwith corresponding map, QR Code capturing village name, survey numbers, total area and name of the tenants.”

- (ii) The Form 'F' prescribed under Rule 132 of the Principal Rules shall be substituted as appended herewith.
