NOTIFICATION

No. /F.No 2-23/2020-Rev. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No.14/3/60-ANL dated 11/04/1960, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby makes the following amendments to the Recruitment Rules to Group C Post of **Surveyor** in the Revenue Department of Andaman & Nicobar Administration published in the Andaman & Nicobar Gazette Notification No.62 dated 16th February, 2011.

Notice is hereby given that the said draft will be taken into consideration after 30 (Thirty) days from the date of publication. Any person/ authorities with respect thereto before the date specified above will be considered by the Administration/ Hon'ble Lt. Governor. Objections and suggestions may be addressed to the Secretary (Rev.), Andaman and Nicobar Administration, Secretariat, Port Blair.

1.SHORT TITLE AND COMMENCEMENT :-

- i. These Rules may be called the Union Territory of Andaman and Nicobar Islands Group 'C' post of **Surveyor** Recruitment (Amendment) Rules, 2022.
- ii. They shall come into force on the date of their publication in the Official Gazette.

AMENDMENTS

2. (i) The existing **column-8** of the **Schedule-III** appended to the Recruitment Rules (herein after called for brevity as the "said Recruitment Rules") shall be substituted as under :-

" Essential

- (i) Secondary School Examination (Xth Std) pass from a recognized Board.
- (ii) National Trade Certificate (NTC) (NSQF Level 4 or 5) of One (1)/two (2) years period of training in Surveyor trade or National Apprenticeship Certificate (NAC) in surveyor trade issued by National Council for Vocational Education and Training (NCVET) from a recognized Industrial Training Institute (ITI)/Registered Establishment.

Desirable

One year experience in the concerned field."
