**ADDENDUM TO EMPLOYMENT NOTICE**

In continuation to this Department's Employment Notice published on 04.01.2023 in The Newspaper "The Daily Telegram", A & N Administration websites([www.andaman.gov.in](http://www.andaman.gov.in)&[www.andaman.nic.in](http://www.andaman.nic.in)), the following clause is added in the aforesaid Employment Notice:


***"As per A & N Admn.'s order No. 2285 dated 01.09.2022, one-time measure for relaxation of upper age limit by two years has been granted for all the Group-C posts. Accordingly, the upper age limit for male shall be 35 years and female shall be 40 years for the post of Regular Mazdoor. The age relaxation available to various categories shall also be applicable over and above the relaxation now given. The crucial date for determining the age limit shall be the closing date for receipt of application."***
